## **Closing Plenary | Caregiving & Wellbeing, and VFN Updates**

According to recent studies, there are more than five million paid caregivers nationally and estimates of unpaid caregivers, including children and adolescents, are in the tens of millions. What are their stories, and how are their experiences interwoven with the

broader context of the cultural and economic conditions in the U.S., leading to a care system tipping into crisis?

This closing session of the conference will explore these questions and the role that philanthropy can play in addressing solutions to this often unrecognized and rapidly increasing need.
